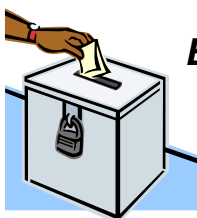

#### Elections April 10th

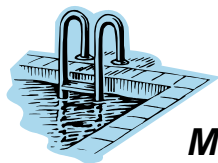
Elections for 2 openings on the Board of Directors will take place at the
