Board Meeting Highlights:

- The Board approved the purchase of a new HVAC system at the Clubhouse. This will eliminate the propane heating

system. The new system will be installed during December and an annual maintenance program will be put in place. This will give the versatility of heat and air conditioning.

- Penny Hulefeld will resign as the Social Chairperson and will assume the responsibilities of the Communication Chairperson. Thus, the 2009 Board member opening will be the Social Chairperson.
- 2009 Budget discussion included the following items:
 - Pool repairs and replacements -
 - Main pool tile repair
 - Main pool deck concrete patching and grate to be repaired
 - Main pool pump electrical wire
 - Virginia Graeme Baker Pool & Safety Act requires the large & tot pool drains to be replaced
 - Tot pool deck to be repaired
 - Re-plumb tot pool to eliminate leaky system
 - Pool entrance gate to be keyed
 - Tennis court cracks to be repaired
 - With the installation of signage, installation of the new security system, new HVAC system, elimination of the propane heating system, and the keying of the pool entrance gate, we are obtaining new insurance coverage bids for 2009.
- Many thanks go out to Penny Hulefeld and all of the volunteers that have assisted with the last few social events - Adult Pool Party, Labor Day Grill Out, and the Halloween Party!! The focus of these neighbors is what helps to ensure that the social events are successful!
